



PRE-EMPLOYMENT TRANSITION SERVICES (Vocational Rehabilitation)

Pre-Employment Transition Services: Vocational Rehabilitation (VR) in collaboration with local education agencies will provide or arrange for the provision of Pre-Employment Transition Services for students with disabilities who are in need of such services and are:

- Eligible or *potentially eligible* for VR services,
- 16-21 years of age (or younger if determined appropriate by the IEP team), and
- Currently enrolled in an educational program.

Services are designed to be an early start at job exploration and to assist students with disabilities in making the transition from secondary to post-secondary education/training and competitive, integrated employment.

Five Pre-Employment Transition Services Activities (with examples):

Missouri Connections Career Planning	Facilitate job shadowing and/or mock interviews	Provide information on institutions of higher education including Disability Access offices	Connect students with local career centers	Counsel students and their families about empowerment through self-determination
Review Labor Market Information	Connect students to career tech and/or other work-based learning programs	Discuss accommodations for success in training and academic settings	Identify social and independent living skills	Identify self-advocacy skills and why they are important
Explore jobs/careers in the community	Identify local businesses for work experience opportunities	Educate and inform students about post-secondary training programs	Identify and discuss employability skills	Help students learn to effectively lead their IEP/504 or other individual planning meetings
